1. The unequivocal Copyright in Law of the Gerhard Reisch Foundation is recognised and respected;
please read copyright declaration of the Gerhard Reisch Foundation (see accompanying document).
2. The scope of a particular permission must be absolutely adhered to.
3. The reproduction of anything originating from the Work of Gerhard Reisch, in whatever form, which deviates from a permission granted requires prior written consent and may invoke the levy of licence fees.
4. The transmission, in any form whatsoever, of all digital information originating from the Work of Gerhard Reisch onto accessible websites in the world wide internet is expressly forbidden.
5. Any reproduction of extracts from images and texts by Gerhard Reisch must, in each individual case, be agreed and approved in advance; likewise in the case of repetition of motifs and words in a publication.
6. The Gerhard Reisch Foundation is to be provided in advance with detailed information in writing concerning the following questions:
 - a. *what is the full name of the publication in which images or texts are to be applied?*
 - b. *who are the authors or editors of the publication?*
 - c. *dates of publication and/or distribution?*
 - d. *what is to be the production quantity of the publication for which permission for copyright useage is being sought?*
 - e. *how many separate images, or texts, by Gerhard Reisch are to be used?*
 - f. *where will images or texts be positioned in the publication (eg. front or back cover, inside cover, etc.)?*
 - g. *what reproduction of extracts of images or texts is intended?*
 - h. *what repetitions of motifs or words are intended?*
 - i. *which "output" medium or printing technique is to be used: **offset, inkjet, laser** or ...?*
 - j. ***all printing techniques** - onto which surface ie. type of paper is to be printed: **uncoated** or **coated**?*
 - k. ***offset only** - how much allowance should be made for "**dot gain**" in 40% halftone dot?*
 - l. ***offset only** - what % "**ink coverage**" is intended?*
 - m. ***inkjet & laser only** - what "**dpi resolution**" is intended for the production?*
 - n. *what are to be the intended production sizes of the images in mm or format (eg. A8, A7, A6, A5, A4 etc.)?*
7. The account of the working costs for arranging and transmitting the appropriate digital information is to be settled in Euros in a convenient way by return - *at the moment the cost per image is € 27 (independent of the size of reproduction up to and including A4).*
8. The reproduction and Copyright of the Work of Gerhard Reisch is to be acknowledged in the same publication in an appropriate manner ...
 - a. *for an article - at the end of the article along with notes and references*
 - b. *on a half or a whole side - when possible in small print alongside the image on the same side*
 - c. *on a cover (back or front) - when possible on the inside cover or by agreement*
 - d. *on a book jacket - when possible on the inside cover or by agreement*
 - e. *in a book - in each case with additional information in brief about the Complete Life Work of G.R.*
 - f. *other possibilities - by agreement*
